OLD BUSINESS

Area Service Meeting Update January 2025

Terry S and New Group:

- Terry is looking to start a new group on the East Side of Nacogdoches.
- Others helped guide him through the process and directed him to the website.
- The area offered to send a starter kit, and Mr. John from Visions of Recovery will donate one.

Lone Star Fundraiser:

- Becki suggested gathering more information before making any decisions, and the area voted not to donate to Lone Star.

Website Update:

- The 10 PM meeting for Living Recovery needs to be removed from the website.

Guidelines Review:

- Becki offered to review the guidelines in March.
- A guidelines review session is scheduled for March 22nd at 1 PM at Another Look. The guidelines will be emailed to everyone ahead of time.

2025 Budget:

- H&I Chair requested a budget change of \$600 per quarter.
- Everyone's budget will remain at \$1790 per quarter, including the prudent reserve.
- Unity Bash activities are adding an additional \$1000 per quarter for merchandise.
- Lit Reps' budgets will remain as needed.

H&I Updates:

- Roy mentioned the need to fill empty racks at probation offices and other locations. Chrysty is still waiting on items from the previous H&I chair but will fill the racks as soon as possible.

PASSED MOTIONS BY GSR'S

- Area is implementing a system where Starter Kits are available at each meeting, and the GSRs will vote on how and when they are distributed, specifically when new groups join the Area. This could help ensure that new groups are supported with the necessary materials and resources as they start.

Clarification of Debt:

The debt belongs to the LSO, and the BOD (Board of Directors) oversees the LSO.

Minutes and Bank Statements on the Website:

The Area has agreed to add the minutes and bank statements to the website. The GSRs voted on this decision at the last meeting.

New Beginnings' Questions Regarding the H&I Budget:

New Beginnings raised several questions about increasing the H&I budget, such as:

- What facilities are currently being visited?
- What expenses does the budget cover?
- How often do we plan to distribute Basic Texts?
- Should the Area body be informed of the H&I Chair's specific allocation plans?

The H&I budget will cover costs like new racks, literature, gas, and other related expenses. Chrysty will be itemizing her expenditures.

Guidelines Review:

The Guidelines Review will take place on March 22nd at 1 PM at Another Look.

Sacred Cow Definition Discussion:

We discussed the definition of a "Sacred Cow" according to the Banner Raid Guidelines.

Starter Kit Availability:

Becki suggested that a Starter Kit should be available at every Area Meeting, managed by the Literature Rep. The GSRs voted in favor of this proposal.

Activities Events and Responsibilities:

Living Recovery will be hosting the Area's Unity Bash. We still need to cover the Halloween Bash and the Campout for the Area. Holly proposed that Living Recovery take over the Halloween Bash, and that members from every group collaborate to plan the Unity Bash to promote unity. GSRs are tasked with bringing back to their groups which event they prefer to host. There may be a change where Living Recovery hosts the Halloween Bash, and Holly's idea for the Unity Bash will be implemented.

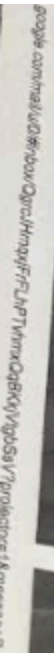
